

**WAGONER YOUTH FOOTBALL ASSOCIATION  
AGREEMENT OF APPOINTEES**

By and between Wagoner Youth Football Association (WYFA), a non-profit Oklahoma Organization whose address is 609 NE 10<sup>th</sup>, Wagoner, Oklahoma 74467, herein after referred to as WYFA, and a resident of the city of \_\_\_\_\_ County of \_\_\_\_\_, State of Oklahoma, herein after referred to as Applicant.

WHEREAS, WYFA organizes and conducts football related programs and activities for youth including programs and activities of flag football, tackle football, basketball, and

WHEREAS, APPLICANT desires to help as a coach or help in some other function or capacity in connection with programs and activities of WYFA under the terms and conditions as provided herein

NOW, THEREFORE, in consideration of the above recitals, the mutual covenants herein contained and other good and valuable consideration the parties agree to the following:

1. Attached hereto marked Exhibit "A" and by the reference made a part hereof, is The Application of Applicant. Applicant warrants and represents that all the information the statements and the contents of said application attached hereto Exhibit "A" is true and accurate to the best of knowledge of the Applicant.
2. Applicant acknowledges that he/she is has received copies of all current rules, and regulations relating to the functions and capacities for which he/she is to help and relating to all other rules and regulations of WYFA and to the League or Conference with which WYFA is affiliated Applicant warrants and represents that he/she has read and understands the contents Exhibit "B" Football, Exhibit "C" Basketball Applicants shall abide by and be bound by all the terms and provisions of exhibit "B" Football, Exhibit "C" Basketball.
3. WYFA has the right to terminate this contract and/or remove Applicant from any team with which Applicant is connected and/or require Applicant to discontinue and or all of his/her activities, duties or functions at the sole election WYFA, with or without cause and with or without notice to Applicant.
4. In the event legal action is instituted by either party, then Applicant shall be responsible for and pay all court costs and litigation expenses including reasonable attorney's fee for WYFA.
5. Applicant and WYFA hereby releases and hold harmless all individuals acting in behalf of WYFA including but not necessarily limited to members of the Board of Directors of WYFA, members of coaching staffs, and team moms.
6. The parties acknowledge and understand that one of the main purposes of WYFA is to provide programs and activities for youth in an effort to help the mental, moral and physical development of said youths. Therefore, the parties hereto shall conduct themselves by actions, as well as words, in a manner that is most conducive toward developing positive mental, moral, physical attributes and characteristics.
7. This Agreement has been entered into in Wagoner County Oklahoma and shall be construed according to the laws of the State of Oklahoma.
8. Should any of the provisions of this Agreement, for any reason whatsoever fail or be declared invalid by final judgment or decree in any court of competent jurisdiction, such failure or invalidity shall not defeat or impair any of the remaining provisions herein contained, but this Agreement shall be construed as if such provisions of provisions so failing and so declared were not herein included.
9. Applicant shall perform the help described herein without pay or remuneration automatically renewing said contract yearly unless terminated by WYFA Board of Directors or receipt of written resignation from applicant.
10. Any controversy arising under, out of, in connection with or relating to this agreement, and any amendment thereof or the breach thereof, shall be determined and settled in Wagoner, Oklahoma in accordance with the rules of the American Arbitration Assoc. Any award rendered therein shall be final and binding on each and all parties hereto and their personal representatives and judgment may be entered there on in any court having jurisdiction thereon.
